

General bicycle rental conditions

Rental conditions

The “Baarer Veloverleih” is a project of GGZ@Work – Recycling and the city of Baar. Bicycles may be rented from the bicycle rental facility free of charge against the deposit of an official identification card (identity card, passport).

Bicycles may only be rented for one day during the opening hours of the bicycle rental facility. Reservations cannot be made.

Bicycle handover

The bicycle is handed over to the customer in reliable and clean condition. The customer must report any complaints during the bicycle handover.

Bicycle return

The customer is obliged to return the bicycle before the end of opening hours. If a timely return of the rental bicycle is not possible for obvious reasons (accident, damage on the bike, thunderstorms, etc.) the bicycle rental facility must be informed immediately (phone 076 444 77 34, latest by 17:45).

The bicycle and bicycle helmet shall be returned in complete and flawless condition. Any losses or damages will be charged to the customer on-site. Non-returns will be reported to the police in Zug 3 days after. An admin fee of CHF 300.00 will be charged.

Liability insurance

The customer is responsible for obtaining appropriate insurance cover. By signing the general rental conditions, the customer confirms possession of appropriate liability insurance covering risks inherent in bicycle rides.

Damage, theft and loss

The customer is obliged to inform the bicycle rental facility about any damages and losses.

The customer shall be liable for theft, loss or any damages to the bicycle and additional equipment resulting from a crash, vandalism, elemental effects, manipulation, impacts sustained during transport, as well as improper or inappropriate use during the rental period. The bicycle must always be locked, even if the customer parks or leaves it only for a short time.

Usage

The customer is obliged to comply with road traffic law and shall use the bicycle in a proper and careful manner.

Using the provided helmet is voluntary. The bicycle rental facility shall not accept any responsibility in this matter.
